Learning from home is another term for the distance learning model developed in Indonesia. Implemented through two approaches, namely (1) online PJJ, and (2) offline PPJ (Kemendikbud, 2020). Distance learning (PJJ) is actually not easy to do, it is almost 80 degrees different from learning face to face. 


Figure 1 The most widely used in learning media
