(1920); Rechtshoogeschool in Batavia (1924); and Fakultait van Letterkunde in Batavia (1940) and had separate libraries in each faculty.




Figure 1 Homepage of FIK UM Palangkaraya e-Library application.




Figure 3 bookshelf FIK UM Palangkaraya e-Library application.




Figure 5 Source: Web & IG Poltekes Kemenkes Palangkaraya.
